## Guidance to 5 Step Risk Assessment Form

1 Hazard	2 Who might be harmed?	3 Is the risk adequately controlled	4 What further action is necessary to control the risk?	5 Who is responsible for doing the work?
<p>Look only for the hazards which you could reasonably expect to result in significant harm under the conditions in your work place. Use the following examples as a guide:</p> <ul style="list-style-type: none"> <li>• Fire (for example from flammable materials)/welding/burning</li> <li>• (for example battery acid)</li> <li>• Gas, fume, dust</li> <li>• Signals</li> <li>• Dogs on pegs</li> <li>• Local hazards- power lines, bridges</li> <li>• Alcohol</li> <li>• Public rights of way / property</li> <li>• Weather</li> <li>• Shoot personnel</li> <li>• Public access</li> <li>• Chemicals and feeds use</li> <li>• Use of tools</li> <li>• Use of ATV and other vehicles</li> <li>• Training</li> <li>• Catering and food supply</li> <li>• Shoot demonstrators</li> </ul> <p><b>This is not an exhaustive list!</b></p>	<p>There is no need to list individuals by name – just think about groups of people doing similar work or who may be affected, for example:</p> <ul style="list-style-type: none"> <li>• Guns</li> <li>• Beaters</li> <li>• Pickers up</li> <li>• Stops</li> <li>• Visitors</li> <li>• Trespassers / antis</li> <li>• Members of the public</li> </ul> <p><b>Pay particular attention to:</b></p> <ul style="list-style-type: none"> <li>• People with special needs</li> <li>• Inexperienced guns, beaters etc</li> <li>• Visitors</li> <li>• Lone workers</li> </ul> <p><b>They may be more vulnerable</b></p>	<p><b>Have you already taken precautions against the risks from the hazards you listed? For example, have you provided:</b></p> <ul style="list-style-type: none"> <li>• Adequate control measures</li> <li>• Adequate information, instruction or training?</li> <li>• Adequate systems or procedures?</li> <li>• Adequate protective equipment</li> </ul> <p><b>Do the precautions:</b></p> <ul style="list-style-type: none"> <li>• Meet the standards set by a legal requirement?</li> <li>• Represent good practice?</li> <li>• Comply with a recognised industry standard?</li> <li>• Reduce risk as far as reasonably practicable?</li> </ul> <p>If so, then the risks are adequately controlled, but you need to indicate the precautions you have in place. You may refer to procedures, manuals, company rules etc giving this information.</p> <p>List other risk assessments, if applicable, for example COSHH, noise etc.</p>	<p><b>What more could you reasonably do for those risks which you found were not adequately controlled?</b></p> <p>You will need to give priority to those risks that affect large numbers of people and/or could result in serious harm. Apply the principles below when taking further action, if possible in the following order:</p> <ul style="list-style-type: none"> <li>• Remove the risk completely</li> <li>• Apply a less risky option</li> <li>• Prevent access to the hazard (for example by guarding)</li> <li>• Organise work to reduce exposure to the hazard</li> <li>• Issue personal protective equipment</li> <li>• Provide welfare facilities (for example washing facilities for removal of contamination and first aid)</li> <li>• Include immediate short-term actions; for example erect warning notice and/or barriers.</li> </ul>	<ul style="list-style-type: none"> <li>• List person who will do the work for immediate actions (for example erect barriers or notice)</li> <li>• List the person responsible for long term actions (for example arrange engineering work to remove hazard)</li> <li>• Record the target date for completing the job</li> </ul> <p>Ensure that the team is briefed on the precautions.</p>
